We built many of the country's signature structures, including the first steel bridge, Manila's water and sewage systems, skyscrapers and national monuments.

We are proud of our rich history and the significant contribution AG&P has made to driving economic growth, creating local jobs and building a new generation of skilled Filipino laborers who can be deployed to infrastructure projects in the Philippines and around the world.

Who We Are



AG&P is a global industrial infrastructure company with three lines of business: Gas Logistics, Modular Construction and FieldCOM Manpower and Onsite Construction Services.

As a gas logistics provider, AG&P is leading the way in the development of efficient and scalable LNG solutions that provide off-grid customers in nascent LNG markets with access to gas. Our unique approach includes designing, building, financing and operating LNG terminals and the onshore delivery networks that deliver gas directly to the end-customer. We simplify the logistics, making it easier for customers to switch energy sources.

In construction, AG&P builds the world's infrastructure in Lego-like pieces in our highly controlled, state-of-the-art manufacturing facilities in the Philippines. We have a track record of delivering award-winning construction solutions including the modular manufacturing of E-houses and complex process modules for LNG liquefaction trains, refineries, petrochemical facilities, mining operations and utilities plants for blue-chip clients globally.

Our FieldCOM division deploys highly trained, experienced professionals and craftsmen to project sites across the world. We offer clients manpower support services comprising onsite construction, commissioning, operations and maintenance of infrastructure at the project site.



State-of-the-Art Manufacturing

With one of the largest heavy fabrication and assembly facilities in Asia, AG&P has the capacity to execute multiple large-scale projects simultaneously. The company owns and operates two manufacturing sites in Batangas, south of Manila, covering 150 hectares with 125,000MT of annual module assembly capacity. Both yards have deep-water access.

The state-of-the-art production shops operate highly advanced automation throughout the manufacturing process, ensuring reliable and efficient 24/7 production. AG&P has complete control of the construction process, closely monitoring safety, quality and costs while accelerating commissioning schedules.

AG&P's streamlined production system maximizes efficiencies and minimizes the risk of cost and schedule overruns in construction and fabrication projects. The fabrication systems comprise multiple automated processing lines for efficient structural steel fabrication including beam coping, cutting and drilling for onshore and offshore infrastructure and separate lines for angles, plates and structural pipes. This process allows AG&P to reduce man-hours, increase productivity and lower costs for customers.



Advantages for Local Projects



AG&P's yards are governed by the Philippine Economic Zone Authority (PEZA), with its own PEZA office in its yard, eliminating time-consuming customs procedures and expediting delivery of imports and exports. AG&P's clients are exempted from taxes and duties on imported materials and do not pay duties on international projects. Priority access is ensured for regulatory affairs governing local projects.

Because of our long presence in the Philippines, we have a deep knowledge of the local regulations, codes and permits required for successful operation of site-based projects. Combined with our stakeholder relationships, ownership of requisite permits and our ability to meet the multitude regulatory health, safety and welfare requirements, we offer seamless and rapid access to staffing.

A majority of our workforce in the yards are drawn from Batangas and the adjoining provinces. We also partner with our clients to recruit local workers at project sites across the Philippines. These workers are then trained by AG&P to meet our rigorous quality and safety standards and in the requisite technical skills required to be deployed.

AG&P has an unparalleled world-leading safety record and has received recognition from both the private and public sectors for its outstanding record of achievement.



World-Leading Safety and Quality

AG&P places a premium on the health and safety of its employees and the protection of the environment for everyone, every time, everywhere.

We hold ISO 14001 and OHSAS 18001 certifications from TUV Asia Pacific Ltd [TUV-SUD] in acknowledgement of our health, safety and environmental management systems and ISO 9001:2015 certification for onshore and offshore modules for the oil and gas, power generation, water treatment and mineral processing industries and the provision of skilled manpower for overseas employment.

Our commitment to the highest standards of health and safety is based on maintaining a positive company-wide HSE culture at all levels within the organization. Our program focuses on:

- Developing and maintaining the competency of our workforce
- Operating in accordance with our HSE management system and compliance with all applicable legal and other requirements
- Identifying hazards and environmental impacts associated with our business and establishing controls to minimize risks
- Maintaining an effective emergency response plan to support business continuity

AG&P invests heavily in skills development through a dedicated, in-house training facility. By conducting training in-house, AG&P ensures all employees are fully compliant with AG&P’s rigorous HSEQ procedures, which is reflected in our daily practices, regardless of location.

AG&P’s Welding Technology & Testing Center has the capacity to train and certify 1,500 highly skilled welders per year.

AG&P is also a licensed outfitter of Membrane Cargo Container Systems having successfully completed Gaztransport & Technigaz (GTT)’s rigorous qualification program. Headquartered in France, GTT is one of the world’s leading designers of cryogenic membrane containment systems for the global gas industry. AG&P was among the first three companies in the world to receive the certification.

As a people-first organization, we offer merit-based career development and growth opportunities. Our workforce uses an electronic learning platform with courses tailored to the skill needs of every employee to strengthen their capability, competency, performance and productivity.



Award-Winning Manpower Support Services



FieldCOM Manpower Services (Field Construction, Commissioning, Operations and Maintenance) provides clients with a scalable manpower model that can be tailored to a project's specific requirements, regardless of location. This reduces local sourcing and construction risk and increases reliability.

Our English-speaking FieldCOM teams are comprised largely of Filipinos who are recruited and trained locally before being deployed to project sites in the Philippines and overseas. Our teams include skilled welders, painters, cutters, fitters, electrical and instrumentation experts, as well as trained engineers, administrators and project managers, who can work within a client's organization or independently.

In 2005 and 2014, AG&P was awarded the Presidential Award for Excellence, the highest honor and recognition bestowed upon licensed overseas recruitment agencies that exemplify the highest standards of ethical recruitment and deployment of Filipino workers for overseas employment.

In 2016, AG&P received the Outstanding Global Player Award from the Philippines Department of Trade and Industry in recognition of our outstanding performance and contribution to the export sector through overseas manpower deployment.



Case Studies

JG Summit Petrochemical Plant Expansion

AG&P has been contracted by CTCI Corporation of Taiwan to undertake construction of the JG Summit Stage 1 Expansion under Package 2, consisting of the Aromatics and Butadiene Extraction Units at JG Summit's facility in Simlong, Batangas, 120km south of Manila. The facility is the only polyolefins plant in the Philippines. Under AG&P's general construction contract, AG&P is responsible for all site works including civil and fireproofing works, structural and mechanical erection, pipe fabrication and installation, insulation and painting, electrical and instrumentation works. The project is expected to be completed in the second half of 2019, with peak manpower of around 1,000 personnel.



Masinloc Coal-Fired Power Plant

AG&P was contracted by Ventanas Philippines Construction, Inc. (VPCI), a subsidiary of Posco E&C, to undertake critical works with a total erection weight of 17,000MT for the Masinloc coal-fired thermal power plant in Zambales, 250 kilometers northwest of Metro Manila. AG&P was chosen because of its outstanding safety record, the ability to mobilize a highly skilled workforce and its commitment to the highest quality standards. The project required us to employ local workers, so AG&P recruited more than 900 workers in the Masinloc municipality including mechanical fitters, scaffolders, welders and boiler makers.



Case Studies



Lube Oil Blending Plant

AG&P was contracted by JGC Philippines to undertake the fabrication, galvanization, delivery and mechanical erection of 2,400MT of steel structures, fabrication and installation of 51,000 dia-inches of pipes, insulation and painting works for Petron's new, world-class Lube Oil Blending Plant (LOBP) in Tondo, Manila. The structural steel works were completed in 2017 with zero Lost-Time Incidents (LTI).

North Mindanao Import Facility Project

AG&P was contracted by Pilipinas Shell Petroleum Corporation (PSPC) to undertake the fabrication of steel structures, mechanical equipment, piping and other construction and installation works for the new motor gasoline pipeline for PSPC's North Mindanao Import Facility Project in Cagayan de Oro, Philippines. AG&P provided a dedicated team including riggers, pipefitters, welders, scaffolders, painters, electricians and foremen, achieving 762,140 man-hours without Lost-Time Incident (LTI). We successfully completed its scope in December 2016.



Case Studies

Malampaya Offshore Gas Platform

AG&P was contracted by Shell Philippines Exploration B.V. (SPEX) to undertake hook-up and commissioning assistance, repair and painting works, and electrical and instrument installation for SPEX Malampaya Offshore Gas Platform Project (MP3) in Palawan. AG&P mobilized over 200 workers from January 2014 to November 2015, achieving 507,484 man-hours without Lost-Time Incident (LTI).



Ichthys LNG E-houses

AG&P was contracted by JKC Consortium (Japan Gas, KBR and Chiyoda) to undertake engineering, procurement construction and installation of mission-ready, bio-secure E-house modules for the Ichthys LNG Project in Darwin, Australia. AG&P manufactured 29 Local Electrical Rooms (LERs) and Local Instrumentation Rooms (LIRs) with a combined weight of 16,515MT at its yards in Batangas. The E-houses were fully-tested, bio-secure and ready-to-operate upon delivery.



Compliance

AG&P is committed to the highest international standards of compliance by creating a rigorous corporate compliance framework and executing robust processes to ensure that all transactions are aligned with applicable laws and regulations, above board and fully transparent. This comprehensive system rests on three critical pillars: Policies, Processes and Systems, and Advisers and Auditors.

Our Code of Conduct and compliance policies are administered by a Chief Compliance Officer dedicated to safeguarding smooth, organization-wide implementation and adherence amongst our employees, contractors, partners and suppliers around the world.

Our policies set standards for prohibited conduct and include a broad range of measures including, among others, providing a venue for confidential reporting of non-compliance or risks thereof; anti-corruption training for personnel across all levels, including AG&P's Directors, Officers, Business Development, Finance and Supply Chain Management Departments; and a suite of business compliance protocols covering AG&P's dealings with third-parties, due-diligence, record keeping, contracts and financial arrangements such as purchasing and procurement. Strict checks and balances have been incorporated towards full compliance across the entire supply chain including reviewing of vendor accreditation, and streamlining warehousing and inspection procedures for maximum efficiency to meet tight delivery deadlines.

AG&P has also established a best-practice procedure restricting the granting of gifts, hospitality or donations to any public official. Offering gifts to other third parties with the intent of influencing the individual is also strictly prohibited.

The company-wide compliance training program is conducted for AG&P's global offices through live or videoconferencing sessions, and via an online platform, and is facilitated by independent experts, Trace International (www.traceinternational.org) and Coffey Burlington (www.coffeyburlington.com).

Our anonymous, confidential, toll-free hotline and online reporting system is hosted by NAVEX Global (www.navexglobal.com). AG&P believes every person in our organization shares the responsibility for compliance. We encourage every employee, regardless of position or location, to report errant or unethical behavior and to protect our company and its business principles.



Sustainability
